## 2022 Vendor Information

### SALES TAX

ALL vendors provide their sales tax permit number. If you do not have a sales tax permit, simply fill out our form which we can provide for you. The form is also available on our website.

### ADMISSION

Admission is **NOT** included in your vendor fee. The fee is **\$10 which is not optional**. Admission income is tracked and expensed out separately in our associations finances.

### CAMPING

The public is welcome to camp on the grounds in a self contained place or in primitive camping where there are no hook ups for \$10.

Camping is available with hookups but these spots are very limited and reservations are required. Vendors are not allowed to set up sales booths in the campground. Camping is available as early as Thursday prior to the event. Reservations for camping in the campground can be made by emailing [farmingofyesteryear@gmail.com](mailto:farmingofyesteryear@gmail.com).

Vendors wishing to camp alongside their booth need to register for a space on the south side of the driveway for \$25/day (see right side of form).

### OFFICE LOCATION

I will be in the office on Friday and throughout the weekend. Due to possible school tours, **vendors who would like to set up on Friday NEED to wait until 3pm to arrive on site**. Feel free to call/txt or find me in the office throughout the weekend with any concerns/questions.

## Vendor Rules & Regulations

- Exhibitors are requested to be present both days. (Required for inside)
- No Refunds
- Pets allowed on leash
- Exhibitors are responsible for maintaining their area during & after event
- Indoor Exhibitors Only: no radios, stereos, electronic, or mechanical equipment in your booth in the barn. If you have a need for this, please register for an outdoor booth.
- Minnesota Law requires a Sales Tax number and permit, we have forms for this that will be given at the event
- Gopher-Hawkeye Power Association assumes no responsibility for loss, accident or other liabilities.
- You will need to pay admission fee of \$10.00 for your admission button. Check in at the office when you arrive or purchase at the gate Sat. morning. Only prepay for your button if you plan to set up on Friday.
- Organizers of Raffles and Bingo/Cribbage may approach you for donations for prizes. Any donations are appreciated, but NOT required.
- In keeping with our 501(c)3 status Farming of Yesteryear can not allow any form of discrimination, political campaign activity or materials, or any violations of public decency in word or items for sale or display.
- Booth layouts are final. Please do not re arrange your booth. If you not satisfied with your booth layout, please talk to me in the office regarding a refund if you wish to not be a vendor due to your dissatisfaction. FOY has offered vendors for three decades and experience tells us what is the best layout.
